## Prerequisites

Students should have successfully completed all the units of the first year and the units of the first semester of the second year. Likewise, students must be able to read scientific papers written in English.

The knowledge acquired during the previous courses about Geography, Anthropology, History, Politics, Economics, ICT, as well as knowledge acquired in specific courses about East Asia are the basis for the analysis proposed in "East Asian Society".

## Objectives and Contextualisation

"East Asian Society" delineates key elements for understanding the sociocultural foundations of contemporary Japanese and Chinese societies, by emphasizing the issue of collective identity in a globalizing world.

The main learning objective of the course is to understand contemporary Japanese and Chinese societies through the sociocultural study of their practices, discourses and institutions. In this approach, the following issues are significant: individual and society, social structure and life cycle, processes of production and reproduction, social and political construction, collective identity and globalization.

The course considers those issues through various epistemological perspectives that are discussed in theoretical and practical classes by means of scientific papers, specialized documentaries, and complementary materials.

From the social sciences approach (especially, from the fields of Sociology and Anthropology), "East Asian Society" reflects upon social and cultural dynamics of East Asia, by analyzing different issues that will help the student to contextualize the knowledge learnt in other subjects of the Degree on East Asian Studies.

## Methodology

"East Asian Society" is divided into theoretical and practical classes. It is very important the use of the virtual classroom since it contains information regarding the development of the course and other related resources.

Practical classes include activities such as screening and discussion of documentaries, and the discussion of compulsory readings. The active participation of the students is expected in both activities. Critical thinking, use of scientific literature and complementary resources will be taken into account in the final evaluation.

The course's methodology strengthen the work with ICT and self-learning tools, the development of practices in line with theoretical classes, and the articulation of one's own discourse.
