Objectives and Contextualisation

Domestic Violence and violence against women is one of the most serious types of crime. The main objective of the module is to understand the specific characteristics of these types of violation of people's rights, as well as being aware of the intervention mechanisms as a whole. The specific objectives of this module are: to know the epistemologies explaining violence against women and within the family, to understand the criminal system's intervention as one in a collection of interventions carried out by public policies, the characteristics and consequences of said intervention, and to introduce gender perspective as a framework in the interventions against violence towards women.
