




Figure 2. Percentage of persons at risk of poverty and social exclusion in Spain by household type (AROPE, 2008-2020)

Note: The abbreviation 'DC' denotes 'dependent children'. The Y axis represents the total percentage.


Figure 3. Percentage of support for the 'Ingreso Mínimo Vital' by party family
