

*Estat i societat civil:
bibliografia temàtica*

Nota sobre el recull bibliogràfic

La distinció entre «Estat» i «societat civil» és, en l'àmbit de les ciències socials, una de les dicotòmies clàssiques més emprades a l'hora d'abordar les transformacions polítiques i socials del món contemporani. Si més no, la bibliografia dels darrers anys és una mostra indicativa de l'ús recurrent d'aquests termes. L'esfondrament dels règims socialistes a l'Europa de l'Est, els processos de transició a la democràcia de l'Amèrica Llatina, els episodis polítics –sovint convulsos i incerts– i les transformacions socials als Estats africans i asiàtics miren de ser compresos des d'una pluralitat de perspectives que, en qualsevol cas, tendeixen a preservar la distinció esmentada. El panorama de les ciències socials, no obstant, s'amplia davant del sorgiment d'estructures complexes de govern (Unió Europea),

de la formació de mercats supranacionals (NAFTA, MERCOSUR, ASEAN, etc.) o dels fenòmens prou coneguts de globalització econòmica. La vella dicotomia s'insereix, doncs, en una anàlisi multidimensional on es redefeixen tant l'articulació dels Estats nacionals com el teixit multicultural de llurs societats.

És per això que aquest recull de publicacions pot considerar-se com a complementari de la bibliografia sobre globalització presentada en el volum anterior («Globalització econòmica i experiència políticocomoral»). Constitueixen, en bona mesura, temàtiques connexes en el camp de la ciència política i la sociologia contemporànies. Així, sense ànim de pretendre ignorar una tradició venerable, ens hem centrat preferentment en la producció recent dels anys noranta i, mirant de seguir els trets de les pròpies temàtiques, en l'àmbit internacional del debat.
