Creative Commons Licenses Recommended in the Universitat Autònoma de Barcelona

Approved by the Academic Affairs Commission on 22 November 2022 and by the Research, Transference and Innovation Commission on 24 November 2022

1. Creative Commons

Open Access promotes free access to academic content in order to improve the scientific communication system. With Creative Commons (CC) licenses authors declare that they permit certain uses, universally (worldwide) and free of charge, without having to contact them, in advance.

Creative Commons is an American non-profit organization established in 2001. The licensing project was born on 16 December 2002 with the help of some Harvard and Stanford academics led by Lawrence Lessig.

Creative Commons offers a variety of licenses. There are 6 standard licenses, adapted to different jurisdictions that can be chosen following a selection process.

Licenses are free and there is no need to register the work in any CC repository or registration. Creative Commons does not provide legal support in case of license violation.

Creative Commons does not offer licenses for software and recommends using the Free Software Foundation (FSF <http://www.fsf.org/>) or the Open Source Initiative (OSI <http://opensource.org/>).

There are four license elements:



ATTRIBUTION



SHARE ALIKE



NON-COMMERCIAL



NO DERIVATIVES

And there are six licenses as a result of the combination of these elements:



Attribution

Common aspects, the six licenses allow: copy or reproduction, distribution and public communication; at the same time, licenses require attribution, they are non-exclusive, they are worldwide, they are not revocable and they do not affect moral rights.

Additionally, Creative Commons offers the Public Domain license, for authors who want to give up all the rights of their works thus entering the public domain, always respecting the current legislation.

2. Creative Commons in the UAB

In the Universitat Autònoma de Barcelona **authors can usually choose the license** (if they have not assigned their rights to third parties) they prefer to publish their own work in the DDD or in the consortium repositories, but it is helpful to have an institutional recommendation as a point of departure.

Taking into account that point 2 of the Budapest Declaration¹ and principle 1 of Plan S² recommend the CC-BY license (Attribution), this should be the basis for thinking about the licenses that could be adopted by the UAB. Necessarily the reuse of information for teaching, learning and research should necessarily be allowed.

CC licenses are especially interesting for teaching uses, since the law is very rigid in this area. Examples: Teaching resources of the Massachusetts Institute of Technology - <http://ocw.mit.edu> or Materials Docents en Xarxa <http://www.mdx.cat/>

This proposal is agreed:

- **CC-By License** (Attribution)



Course materials (teaching and student guides...), institutional documents, periodical publications published by the UAB.

- **CC-By-Sa License** (Attribution – Share Alike)



Final degree projects, master's thesis and research documents (thesis, working papers, articles, contributions to conferences...)

- **CC-BY-NC-SA License** (Attribution – Non commercial – Share Alike)

- **CC0 License** (Public Domain)
