Executive Summary

The purpose of this deliverable is to provide the information concerning the opinions/approvals by ethics committees required in the Ethics Summary Report sent by the European Commission on 21st November 2019. This deliverable contains the ethics approvals/positive opinions from ITFLOWS Consortium Partners involved in the interviews with migrants, refugees and asylum seekers (T.3.4). The participation of vulnerable individuals in this research activity entails the highest potential ethical risks in the context of ITFLOWS. The three NGOs that will conduct the interviews with migrants, refugees and asylum seekers – Associazione della Croce Rossa Italiana (CRI), Open Cultural Center (OCC) and Oxfam Italia (OIT) – have been requested to identify the competent ethics authority of their institution and provide their ethics positive opinion/approval before conducting the interviews. Besides, the Istituto Affari Internazionali (IAI), involved in the design of the interviews and qualitative analysis, has also been asked to identify its competent ethics authority with the aim of providing the ethics approval/opinion.

Introduction

In the ITFLOWS project, several activities involving human participants have been planned; namely, workshops, seminars, webinars, online forums and interviews with migrants, refugees and asylum seekers. Unlike other activities involving professionals and stakeholders who are not in a situation of vulnerability, the interviews conducted within ITFLOWS require a more careful and individualised approach.

Given that the interviews with migrants, refugees and asylum seekers entail the highest potential ethical risks in the context of ITFLOWS, the ethics lead partner of the project (IDT-UAB) has sought ethics positive opinions/approvals from ITFLOWS Partners involved in these interviews (T.3.4) in order to comply with the imposed ethics requirement nº 2. This is the solution adopted by the ethics lead partner to overcome the difficulties of obtaining an ethics approval/opinion of a national competent authority for the research with humans: i) lack of existence; ii) lack of expertise; and, iii) lack of jurisdiction of such national competent authorities.

Therefore, the three NGOs that will conduct the interviews with migrants, refugees and asylum seekers – Associazione della Croce Rossa Italiana (CRI) Open Cultural Center (OCC) and Oxfam Italia (OIT) – have been requested to identify the competent ethics authority within their institution and to provide an ethics opinion/approval before the start of the interviews. In addition, the Istituto Affari Internazionali (IAI), tasked with preparing the interview grids and performing the qualitative analysis of the interviews (T.3.4) and coordinating WP3 tasks and ensuring methodological and analytical complementarity and coherence (T.3.5) has also been asked to identify its competent ethics authority with the aim of providing the ethics approval/opinion.

The following internal bodies have been identified by the abovementioned ITFLOWS Partners as competent Ethics Authorities: the President of Associazione della Croce Rossa Italiana (CRI), the Open Cultural Center Internal Ethics Committee (OCC), the Oxfam Italia Safeguarding Committee (OIT) and the IAI Supervisory Board (IAI).



SECTION 1 - Copies of opinions/approvals by ethics committees and/or competent authorities for the research with humans

With the aim of ensuring that the identified Ethics Authorities had all the necessary information to provide such an opinion/approval, the ethics lead partner (IDT-UAB) submitted to the involved ITFLOWS Partners, a request letter signed by the Coordinator of the ITFLOWS Project informing the Ethics Authorities of the aim of the ITFLOWS Project and the ethical requirement imposed by the Ethical Panel of the European Commission regarding the submission of an opinion/approval by a competent Ethics Authority (see Annex 1). In addition to this request, an information package was also attached. This information package contained the following documents to be reviewed and assessed by the Ethics Authorities in order to provide an informed ethics opinion/approval:

- The **specific ethical guidelines for conducting the interviews** contained in Deliverable 2.1 (D2.1) provided by the ethical lead partner (IDT-UAB). (See Section 5 of D2.1).
- The **Recruitment Plan** for the interviews focusing on the recruitment of the interviewing team and the research participants. This Recruitment Plan can be found in Section 3 of D10.1 and has been designed by the ethical lead partner of the Project (IDT-UAB) in close collaboration with all the Non-Governmental Organisations (NGO's) in charge of conducting the interviews.
- The **Incidental Findings Policy** designed for the Project, in particular for providing specific guidelines to the interviewing team in order to address incidental findings in the context of the interviews with migrants, refugees and asylum seekers. (See Section 5 of D10.1).
- Information regarding the procedures for obtaining **informed consent** from the research participants. (See Section 1 of D10.1).

Therefore, the Committee has reviewed the following documents:


- Ethical issues in ITFLOWS;
