Changes in Journal Privileges

Subscriptions to the NOTICES and the BULLETIN are included in the dues of all ordinary and contributing members. In connection with the PROCEEDINGS (P), the TRANSACTIONS (T), and MATHEMATICAL REVIEWS (MR), the various options listed below are now available. Four volumes of the TRANSACTIONS will be published in 1960. The members' price per volume is \$4.00. (See also Notes 3 and 4 on the reverse side.)

A request for a change in your present journal privileges must be received in the Headquarters Offices before January 1, 1960.

The above schedule of charges is not applicable to retired members whose dues have been remitted. (Note 5 on the reverse side.)

Contributions

The publication activities of the Society are conducted at a heavy net loss. In the face of sharply increasing publication costs, the dues of the Society have remained constant for a number of years, and it is hoped that they can be held at present levels for some years more. Also the members' subscription prices to the research journals have been held constant in recent years. (In the case of the TRANSACTIONS, the members' price per volume was actually reduced three years ago.) Under the circumstances, the generosity of individual members in paying more than the minimum dues is an important factor in meeting the publication deficit.

A member becomes designated as a Contributing Member if he volunteers to pay dues of at least \$20 per year. A Contributing Member is designated as a Sustainer of the Society if his dues are at least \$100, and as a Patron of the Society if his dues are at least \$500. You are respectfully urged to pay more than the minimum dues for ordinary membership if you can afford to do so. Contributions to the Society are of course tax-deductible.

NOTES

(Based upon Articles VIII and IX of the By-laws, and on related actions of the Board of Trustees.)

NOTE 1. The annual dues of an ordinary member are at present \$14. Special rates are offered to members of organizations with which the Society has reciprocity agreements. The dues of a nominee of an institutional member are remitted, as are those of a life member, and of a retired member whose paid membership extended over at least twenty years (see NOTE 5 below).

NOTE 2. An applicant is admitted to ordinary membership immediately upon election by the Council and upon the discharge within 60 days thereafter of his first annual dues. The first annual dues ordinarily apply to the year of election, except that if any applicant is elected after August 15th of any year he may elect to have his first annual dues applied to the following year.

NOTE 3. Subscriptions to the NOTICES, the BULLETIN and the PROCEEDINGS are included in the dues of an ordinary or contributing member. A member may substitute either MATHEMATICAL

REVIEWS or the TRANSACTIONS for the PROCEEDINGS by paying a premium to dues of \$10.00.

NOTE 4. Members' subscription rates are at present as follows: NOTICES, \$5.25; BULLETIN, \$5.25; PROCEEDINGS, \$6.00; MATHEMATICAL REVIEWS, \$16.00; TRANSACTIONS, (4 vols.), \$16.00. The schedule of members' subscription prices and premiums to dues for journal privileges has been worked out so that if a member wishes to subscribe to two or more journals in addition to the NOTICES and BULLETIN, it will make no difference to him financially which one he accepts as a privilege of membership.

NOTE 5. Retired members whose dues have been remitted (see NOTE 1) will receive the NOTICES but not any of the other journals unless they subscribe to those journals.

NOTE 6. Nominees of institutional members whose dues have been remitted will ordinarily receive the BULLETIN and the PROCEEDINGS as well as the NOTICES as privileges of membership. How-

ever a nominee may substitute the TRANSACTIONS or MATHEMATICAL REVIEWS for the PROCEEDINGS, provided notification is received in the Headquarters Offices of the Society before the beginning of the calendar year in which the substitution is desired. He must then pay the usual premium of \$10.00.

NOTE 7. The annual dues of ordinary and contributing members are payable after October 1 of the preceding year and due by January 1 of the year to which they apply. If the minimum annual dues of any member remain undischarged beyond what the Board of Trustees deems to be a reasonable time, his name shall, after due notice, be removed from the list of members. If a member wishes to discontinue his membership at any time, he is expected to submit his resignation in writing to the Society.

NOTE 8. A membership card and/or emblem will be issued only to a member not in arrears in his account with the Society.
