UAB Libraries Laptops Terms of Use

Article 1 - The Laptop Loan Service aims to facilitate the use of laptops to users of the Library Service, for exclusively academic and research purposes, within the UAB library premises.

Article 2 - The laptop loan service will be carried out in the different libraries of the UAB and will entail the delivery, under a loan and for a certain time, of a laptop in perfect conditions of use and operation.

Article 3 – Laptops can be borrowed for a maximum period of four hours and must always be returned to the loan desk of the library, by the specified due time.

Article 4 - During the loan period, the user will be solely responsible for the custody and good use of the laptop and, therefore, must not manipulate the hardware or software installed, nor lend the computer to any other user of the service or to any third person.

Article 5 –The use of the laptop is restricted to the library premises and is exclusively for academic and research purposes, so it is strictly forbidden to remove it from the library premises or to use it for any other purpose.

Article 6 - Any malfunction of the hardware or software must be reported immediately to the library staff. Any malfunction detected once it is returned, without reporting it, will be considered a misuse and Article 9 of this Regulation will be applied, if appropriate.

Article 7 - In case of delay in returning the laptop, the user library card will be blocked one day per hour or fraction of delay.

Article 8 – In case the user is blocked or has an overdue loan from the Library Service, the user may not make use of the Laptop Loan Service.

Article 9 - In case of damage, serious deterioration, loss or theft, the borrowing rights will be suspended until the user has replaced it with another one of similar characteristics or has paid the cost of replacement to the corresponding library in a maximum term of 30 days, notwithstanding the opening of a disciplinary record, if applicable.

Article 10 – In all matters not expressly provided for in this regulation, relating to user obligations and non-compliance with the conditions for laptop use, the provisions of the Library Service Regulations must be applied.
