If we do not receive the paper before this deadline, this will be understood as your withdrawal from the conference. The Organizing Committee will evaluate all submissions; if they fulfil the necessary academic conditions, they will be accepted for the discussion panels. The Organizing Committee makes no commitment to publish all the submitted papers. However, it reserves the right to select some of these –in accordance with their authors' agreement- for the subsequent publication. A decision on submissions will be notified to submitters by early November 2017 in order to complete registration (see below).
