


Excavations at La Bastida, 1950.

Thursday, Nov. 9th. Work began on the site at 9 a.m. by Francis Toda, who is in charge of the excavation, and myself, with five men, two digging, and the others clearing the earth and stones. We began digging in Square E 14, to the North of the excavation in the previous campaign; this square, of which the Southern portion formed the limit of the work at the last dig., was marked out in accordance with the published plan. Later we proceeded to mark out two further squares of 3x3m to the S., adjoining squares E 14 and E 13.

In the centre of Square E 14 appeared a layer of loose stone which appeared to belong to a fallen wall. Beneath these came vestiges of some pieces of gypsum, on the under side of which was a hollow. Suspecting a possible interment, we decided to level out the whole square before proceeding to the investigation.



Afternoon The work of clearing Square E 14 continued. In the Northern part we struck virgin soil rising steeply with the hill. At the base of this appeared the gypsum slabs of a cut at a depth of 1m. 15cm.



The area was cleared and short grass was visible
of the slabs cleaned and photographed. (Nos 1 & 2
of my first roll). The covering slabs were then
lifted without mishap, and the cist (measuring about
above (c) appeared filled with fine damp soil.
The measurement in (a) are taken from the

cast after the removal of the covering slab.
We next proceeded to clean, the area E. of
the cast including, stone previously considered to
be a wall running E. from the ~~south~~ Southern edge
of the cast.



We then began removing the earth of the
cist and clearing it. There appeared the top rim
of a pot, probably a bowl - the N.E. corner, a

thin, lying on its side ⁸ with the mouth closed with a stone. The pot were photographed *in situ* (Nos. 6 & 7 of Roll I), and left (it being then almost dark) for further work in Morley.

In the meantime the cist in E14 had been cleared out. The skull was very much crushed and by the pressure of the Southern slab, which had fallen in somewhat. We had given it two coats of glue to harden it but nevertheless it fell to pieces despite all efforts to save it. The remaining bones all came out in a very bad state. Many could be seen to have been split or crushed by the pressure exerted by the slab at the head and other bones in extraction.


Near the skull was a small coppered axe, and from the pelvis region came one or two minute fragments of copper.

The clearing of the soil produced nothing but minute fragments of the skeleton and a possible bird-bone. A small amount of soil remains in the cist, to be dealt with in Morley.



The fragments of the skull and skeleton were packed in cotton bought from Totana in the morning, and the pottery and small finds of the previous days made into packages.

Sunday 12th Nov. Torté & I went for walk ~~near~~ to the Cofradía de Montaña behind the farm. Discovered one fragment of Argive pottery type "La Bastida" in small cavity called "Cueva Negra".

Morley, 13th Nov ⁹ Morning Some fragments of human bone, including part of a mandible appeared in E16. Also a few fragments of pottery, and but having no connection with the bones, which appeared to have no protection. 8 men working.




Querns from packing of Cist S1-50




Tuesday, 14th Nov. Morning 7 men working, boys having gone for provisions. Took 2 photographs of "doorway" (E14), the first facing N. & including general view of work, the second a detail, facing S. (Nos. 8 & 9 of Roll I).

Squares E14, 15, 16, and Squares D14, 15, 16 cleared out without further find. At this point 2 men began the work of clearing the surface of square F14, 15 of large stones to leave it clear for excavation.




Afternoon Fragment of what appeared to be a large iron appeared in F 1&2 at about 1 p.m. This afternoon the iron was brought to light, and also the fragments of a further iron at right angles to it. The first iron had been combed by the stone above it, and the second was in an even worse state. In the angle between the two, and to the west, appeared fragments of various sorts, some of very fine iron, and with unturned edges, others coarser. Photographs were taken of the whole complex. (Roll I, 10, 11, 12)




Wednesday, 15th Nov. Morning 8 men working.
A few men, oriented NE. - S.W. came to light in
Square E 13, N.W. sector. This was very much
smashed by the pressure of the large stones which
packed it in. The clearing of this I (the best
preserved), 52-50, was proceeded with, and the
skeleton, much smashed, was partially uncovered. It
was about lying, the pelvis in Totana.

Afternoon. The cleaning of 52-50 continued, and the were photographed with the Contax.

Thursday, 16th Nov. Morning 8 am working.
The E-W wall in E 14 was repaired, the doorway being
filled in with stone, and a further layer of stones and
earth being placed on top to preserve it.


S4-50 cleared. Yielded nothing, but smashed fragments of the top of the urn were found throughout. No trace of shelter.

S5-50, an urn smashed on top and on the E. side appeared with same orientation as S4-50, to S.E. in same square. The mouth in this case was to the N.W.







Friday, 17th Nov. Morning 8 am working.

The work of clearing S2-50 and S3-50 was continued and completed; the skull in both cases was found intact. The sieving of the soil in S2-50 yielded two more fragments of the copper ard, and one further stone head. Also 6 more head, two being bone, the rest stone, spread below the smashed pieces of urn.



The work of clearing F15 was begun, and toward the end of the morning a copper ring was found in the débris below.




Monday 20th Nov Morning - Digging

continued in F 11 and F 10. The G squares were marked out for further advances. 10 men working.

I began the cleaning of a small pot which appeared in the G 12 wall on Saturday afternoon and photographed it (Nos 8, 9) 10, 11, 12 of Roll II). The contents, except for soil, was one or two minute fragments of bone and charcoal.

Afternoon F 11 and 10 finished, also G 10 and 11, and digging begun behind the wall in G 12 and 13. In the W part of G 16 and 11 appeared a wall of smaller stones running N.S., and with other walls beginning at right angles.


angles in an Easterly direction. These terminated after a few centimeters, however. The N-S wall was a remnant, only one stone thick of the labyrinth.

In G 13 there is an area which appears to have been periodically disturbed. From this area came a small dagger of copper, with 3 iron pins, but only one remaining rivet. A piece of bone also appeared. An area exposed in the SW corner of G 12, apparently entering H 12.




Copper "dagger" from G 13.

Tuesday, 21st Nov. Morning 10 men working. Work continued behind wall in G 12 and 13. A fragment of wall found, which was slightly visible above ground previously, having been placed in a previous excavation (i.e. bombardment!). The reverse face of the original wall was cleared up and the cleaning of the G 12 wall began.



Afternoon Cleaning of G 12 wall (which proved an exceptionally large one) finished. Work began on G 14, 15, 16. One fragment of the small "mortar" found in ~~G 15~~ G 15.

Part of G 12 wall was found to run into H 12. The remaining part of F 16 finished.





Wednesday, 22nd Nov Morning. Proceeded to the clearing of H 15, 16. Photographed wall (G 12, 14, 15), with storage, plate and my compass (Roll III, 1, 2, 3). Dimensions of G 12 wall: length 0.85, width 0.70, mouth 0.65. Depth 0.90. 16 men working.

Afternoon Work in H 15, 16 continued, and
a further run (v. smashed) came to light, in H 15,
~~upped~~ and beside it a medium sized open.
The G 12 m was cleared out, revealing two skeletons (with
a skull v. incomplete) and a magnificent cup (perfect). This
is the first complete cup to appear at La Bostre.

Thursday 23rd Nov Morning - 10 men working.
Work continued in H15 and commenced in H16.

Saturday, 2nd Dec. Morning - 10 men working. The clearing of J 14, 15, 16 finished, and that of J 13, 12 embarked upon. There is a sudden rise of the ground above the J line, and for this reason the layer is very sheltered so that the clearing of these squares proceeded rapidly. The two walls found yesterday were followed through these squares, but the further North they recurred shortly after entering J. The fragment of a pot was found on the binding line between I & J 13. This was removed, and found to be very sherd. They were surrounded by a mass of fine hardened clay. Depth approx 1.80


The entombed Sg-52, Sg-50 were cleared completely. Apart from one or two bones and a sherd or two, nothing else appeared in this process. Sg-50 appears only to contain remains of one skeleton, which was incomplete. The lower jaw of one of the skulls (prob. Small I), which seem to be that of a youth) is still missing.


Sunday, 3rd Dec. Visited Cobijo de Tuan Coimba for second time, but found nothing notable except the pits of earlier excavator

Monday, 4th Dec. 10 men working. J 11 + 10 cleared & found to be completely sterile like most of J 12 + 13. The clearing of the stone form A, B + A' 14-16 began so that these can be excavated & left clear for the future.



The work of clearing the cist continued. About 12,20 the skeleton was quite well visible, and a further pot, at the side of the first, had been uncovered. At this point we began photographing the remains (nos 3, 4 & 5 of Roll I).

Meanwhile several fragments of pottery (one with unperforated lug, & one of the fine black polished ware) and 3 more querns (one broken) had come to light in Square E15 all near the hearth, and at about the same depth as the base of the cist.

The cist was photographed with the plate camera, and we then proceeded to remove the two pots. The larger contained one or two small fragments of bone among the soil which filled it.

Saturday, Nov. 11th. The cist was dismantled in my absence in Totana. The two largest stones of the packing proved to be very large querns. The broken part of the wall revealed in the last campaign in E14 turned out to be a doorway. This became clear when a few loose stones and some of the earth had been removed.

Friday, 17th Nov. Morning. 8 men working. The work of clearing S2-50 and S3-50 was continued and completed; the skull in both cases was saved intact.
