BRIEF DESCRIPTION OF SUBJECT

This is an introductory course to the field of pragmatics. It focuses on the development and growth of the discipline over the last fifty years. Special attention is paid to looking at the ways in which the role of pragmatics has been defined within linguistic theory. The second part of the course will be devoted to examining the most significant lines of inquiry within the field of discourse analysis at present, such as the study of talk in institutional settings and multilingual communication.

OBJECTIVES

- Present an overview of major approaches and topics of research in the fields of pragmatics and discourse analysis.
- Focus on core problems pragmatic theories/theories of discourse seek to address and examine them critically.
- Introduce students to the practice of fieldwork and data collection techniques.
