3. Avaluació

The class is based on continual assessment and requires participation in the class activities as well as outside of class virtual activities and an autonomous learning programme to be established as part of individual portfolios. Part of the class is dedicated to language analysis, of which the students are expected to be able to apply the knowledge outlined in the presentations to their own work. A certain part of the face-to-face intervention is dedicated to error analysis which should later be applied to individual cases by each student. Progress is measured by quality of work shown throughout the course.

Assessment is based on continual assessment. The exact percentages of each activity will be discussed at the beginning of the semester, however, the all of the above activities will count. Assessment from your peers will also be part of the final evaluation. The final exam will count 35% of the final mark.

NB: If the continual assessment part of the course is passed, the student has the choice of sitting the final exam or taking the mark received during the continual assessment as the final mark. The final exam can bring up the final mark. If the student has not passed the continual assessment of the class, the exam counts as 100% of the final mark.
