Objetives and skills

The objective of this module is to present the key debates in the discipline concerning the notion of democracy and actually existing democratic systems. This includes dicussions concerning concepts such as democracy, democratic quality and citizenship; the conditions for development and stability of democratic systems; the consequences of different types of democracy and their institutional arrangements for political life; the tools and channels for citizen participation in decision-making processes; and the challenges faced by contemporary democratic systems.

Contents

These contents are structured around four main axes:

- 1.- The emergence and structuring of democratic systems, in both historical and institutional terms. (Prof. J. Etherington)
- 2.- The interaction between Welfare policies and the notion of citizenship (M. León).
- 3.- Citizenship and community (A. García Ruiz)
- 4.- Links between citizens and the political system: parties, representation, media. (Profs. J.Botella, A. Bosch)

Evaluation

Overall marks for the module will be based on the active participation of students in class and on an essay which demonstrates in-depth knowledge of the literature discussed and which forms the basis for a reflexion on themes not dealt with by the module. The content and titles of these essays will be determined by the tutors of the module and individual students.

The evaluation of the module, then, will be based on the following elements:

- Attendance and participation in class: 25%
- Exam 30%
- Essays 45%
