Prerequisites

Graduates in Biochemistry, Biology, Biomedical Sciences, Genetics, Microbiology, Chemistry, Computer Science, Physics, Veterinary Medicine or Pharmacy.

English proficiency is required to read and understand scientific papers that will serve as basis for the preparation of the final project.

Objectives and Contextualisation

The main objective of the Final Master is to learn firsthand the scientific method. Thus, the students should participate in the design, implementation and presentation of theresults of a research project or work placement.

The Master Thesis is the preparation and public defense of a lab work on a topic related to biochemistry, molecular biology or biomedicine where students can integrate a set of skills and competencies acquired in the program.

In the Master Thesis the students must demonstrate:

- a) They have acquired the skills trained in the master
- b) Their reflective and critical capacity
- c) Its ability to raise a research problem, design a project to find answers, to critically analyze the results and conclusions based and proven.
- d) Ability to present and defend the results.

Skills

Content

The written report of the Master Thesis will have the following characteristics:

- 1. Structure: While accepting different types of Master report according to the conducted research, we believe that their content should have the following chapters:
- Summary (maximum 200 words)
- List of Abbreviations
- Introduction
- Objectives
- Material and Methods
- Results
- Discussion
- Conclusions
- Bibliography
- 2. Extension: The report must not exceed 15,000 words, including all sections, even the bibliography. The

number of figures is not limited but we advise that the total report once printed does not exceed the equivalent of 30 pages.

3. Language: You can defend it in Catalan, Spanish or English.

The defense of the Master Thesis should consist of a brief presentation (between 15 and 20 minutes) to an Evaluation Committee, formed by three doctors from the Master's. The members of the Evaluation Committee may ask questions and discuss issues with students both from the oral defense, as well as from the written report. This oral defense will be public, and other Master's teaching staff in the room may also ask additional questions realted to the students' work.

The Master's Thesis can be presented in Catalan, Spanish or English.

Evaluation

To be evaluated, the student must deliver to the Coordinator of the corresponding specialty the final report, before the established deadline. In addition, the student will have to make the oral presentation. If any of these requirements is not fulfilled, then the final grade will be "No avaluable".
