Objectives and Contextualisation

The course is integrated into the topic "Journalistic Production". This topic in the Journalism Degree consists of the following contents:

The course, within the training block, is aimed to provide the general concepts and theoretical foundations for the conception and production of radio and television news program.

The very fundamental basics of broadcast journalism in news programs are subject of the course.

Evaluation

The acquisition of skills and knowledges through the course will be determined by different methods:

The final grade will be the result of the weighted sum of the partial grades. If the student fails in more than one part, the calculation of the final grade will not be made. As a result, the course will not be approved.

- b) the failed exam (above a degree of 3 out of 10).
- c) raise the degree from 8.
