Objectives and Contextualisation

"Commentary of Literary Texts" is integrated into the subject of Texts Commentary, which is part of the 108 credits of compulsory education of the Spanish Language and Literature Degree, which the student attends along with other Spanish language subjects.

The main objectives of the course are to familiarize the students with the text comment, providing them with the necessary tools to do it, in order to enable them to consolidate the necessary skills to produce a text comment on any of the periods of Spanish literature .

Content

Methodology

The learning of this subject by the students is distributed as follows:

Directed activities (35%). These activities are divided into master classes and seminars and classroom practices led by the faculty, in which theoretical explanation is combined with discussion of all types of texts.

Supervised activities (10%). These tutorials are programmed by the teacher, dedicated to correcting and commenting on problems at different levels of literary analysis.

Autonomous activities. These activities include both time devoted to individual study and production of reviews, papers and analytical comments written, as well as oral presentations.

Evaluation activities. The evaluation of the subject will be carried out through written tests.

Assessment

The evaluation will consist of two written text comments delivered throughout the course (25% each), and a final written test (50%).

In order to pass the subject the student must achieve a final grade of at least a 5.0.

The final grade of the subject will be calculated by making the average between the notes of the text comments and the note of the test. The spelling and writing errors will result in a markdown.

The activities proposed are mandatory. Therefore, whoever does not complete them will be considered as not evaluable.

The student who does not complete the activities will be considered not evaluated.

In order to be eligible for re-evaluation, students are obliged to attend all the evaluable tests and exercises.
