Objectives and Contextualisation

The purpose of this subject is to enable students to apply and complement the knowledge acquired in their academic training in relation to the world of translation and interpreting, favouring the acquisition of skills to prepare them for the exercise of professional activities, facilitate their employability and foster their entrepreneurial capacity.

At the end of the course, the student will be able to:

- Demonstrate knowledge of the functioning of the translation and interpreting labour market.
- Manage problems related to the practice of the profession of translator and interpreter.
- To professionally apply knowledge in the fields of translation and interpreting.

Methodology

The course is divided into 1 "Professional Orientation" credit, which is mainly directed, and 5 internship credits in an entity or company, for the development of which a total of 100 hours of work in the headquarters of the entity or company or online distance working is foreseen, the latter depending on the requirements of the placement offer assigned to the student by the course coordinator.

Assessment

Qualifications

- The internal tutor will assess the professional folder using an online form, accessible from the subject's website. This grade will count towards 25% of the overall grade.
- The external tutor will assess the tasks carried out in or for the entity or company by means of an online form, accessible from the subject's web page. This grade will account for 65% of the overall grade, bearing in mind that the grade corresponding to this percentage is the result of the assessment of a series of tasks, the number of which varies in each case, which is why there is no fixed breakdown of them.
- Professional orientation sessions: During the year, several professional orientation sessions will be organised. The students must attend the obligatory professional sessions, which will be previously announced by e-mail, and will take place on Wednesdays (13:00-14:30), when other classes are not scheduled. Within one week following the session, the student must submit a summary-evaluation of a minimum of 10 lines. Summaries from students who did not attend the sessions will not be accepted. The grade will account for 10% of the overall grade

Retake

Given the nature of the subject, it is not possible to resit it within the same academic year, insofar as "assessments linked to an academic and/or professional task of six-monthly or annual duration are excluded from retake."
