Methodology

"Journalistic documentation" is a subject eminently practical, that from the methodological point of view, pursues the learning of the students through the application of the theoretical contents that integrate it, to the

resolution of practices, exercises and practical cases related with the search for information. These activities are always presented contextualized in the realms of journalism and communication in general, which allows students to discover the usefulness and role played by documentary techniques in their future profession.

Theoretical and practical sessions are held in computer rooms. Practical work is always in pairs and, in some cases, in small groups. The purpose of this work system is to promote peer learning, which the teaching team considers highly effective and enriching.

To the extent possible, it will be attempted to count, in some of the sessions, with the presence of professionals of the journalistic documentation and journalists, who will share their experiences with the students.

Within the framework of the subject, the Virtual Campus-Classroom MOODLEis an indispensable and dynamic tool. Students must visit it often, to consult the documents and participate in the various activities to follow the subject correctly.

The communication with the teachers of the subject will have to be done exclusively through the mail of the Campus (not to the institutional electronic mail of the teaching staff). Students will also be able to attend in person, if they so desire, in the tutoring hours of the teachers previously established.

The content of the subject will be sensitive to aspects related to the gender perspective.

Assessment

EVALUATION

The subject follows the continuous evaluation system. The minimum qualification to pass it is 5 points (out of 10). The evaluation elements that are considered are the following:

Individual proof of knowledge (40%): an exam will be carried out on the theoretical and practical contents worked on the subject. It will be held on Monday 16 December 2019(morning group) and Thursday December 19, 2019(afternoon group). (These dates will only be changed in case of an incident). It will be necessary to have a note greater than 4 to do the average with the rest of the elements of the continuous evaluation.

Synthesis project (30%): team activity (double pair) and during the last sessions of the course. Requires the integrated application of the contents worked. It consists of documenting a topic for the production of a journalistic product. Its evaluation will take into account both the formal presentation and the content and to a lesser extent the resulting journalistic product. The oral presentation will be on Monday January 13, 2020 (morning group) and Thursday January 16, 2020.

General follow-up of the subject (30%): this concept values the effort, dedication and the adequate management of the time of the student. It contemplates the attendance to the practical sessions, its realization, the punctual delivery on the expected date and the self-correction based on the solution provided by the teaching staff. The rest of the activities proposed by the teaching team will be taken into account (exercises, readings, preparation of subjects, exhibitions, debates and discussions, etc.), in the same terms as in the practical sessions. Each failure by the students will be penalized with 1 pointon the Follow-up note.

Since it is a face-to-face subject, it is necessary to attend the theoretical classes and the totality of the practicesin order to obtain the final grade and that all the elements of the continuous evaluation have been carried out.

Complementary exercises may be proposed, which will always be volunteers with the aim of raising the final grade.

RECOVERY SYSTEM

The student will be entitled to the revaluation of the subject if he or she has been evaluated of the set of activities the weight of which equals a minimum of 2/3 of the total grade of the subject.

To have access to revaluation, the previous grades should be 3,5. (Consell de Govern july 12, 2017, art 112)

The recovery will consist of a single test about the theoretical and practical content of the course and independently of the score obtained in this exam, its final grade will be approved (5 or 6 points).
