# Objectives and Contextualisation

This course aims, from the perspective of Social and Cultural Anthropology, to introduce students to the different areas of socio-cultural intervention, whether in the process of analysis or diagnosis of the problem, and in the definition of social policies from a perspective of social and cultural diversity, with special attention to issues related to ethnic minorities, migrant population and other groups excluded or at risk of exclusion.

## Competences

- Apprehending cultural diversity through ethnography and critically assessing ethnographic materials as knowledge of local contexts and as a proposal of theoretical models.
- Assessing in theoretical, methodological and ethical terms the anthropology investigations aimed to basic objectives or oriented to intervention.
- Developing critical thinking and reasoning and communicating them effectively both in your own and other languages.
- Intervening in different contexts and areas of implementation of Anthropology (intercultural relations, development and cooperation, kinship, health, education, social use of space and other intervention areas)
- Students must be capable of collecting and interpreting relevant data (usually within their area of study) in order to make statements that reflect social, scientific or ethical relevant issues.
- Students must have and understand knowledge of an area of study built on the basis of general secondary education, and while it relies on some advanced textbooks it also includes some aspects coming from the forefront of its field of study.

#### Assessment
