Objectives and Contextualisation

In this module the student will carry out an individual investigation under the supervision of a tutor on a topic related to the contents of the master, previously agreed upon; He will have to demonstrate his ability to propose research objectives, apply the appropriate methodologies and obtain learning results that respond to the objectives set, as well as to expose and defend the work done before a court.

Content

The module is structured in three blocks:

- Seminars of methodological training
- Elaboration of the Master's Final Project
- Defense of the Master's Final Project before a court

In the seminars, of obligatory assistance, the guidelines on methodologies to elaborate the TFM, the background of information and the models of presentation and defense are given. The main lines of work are presented and the students contact with tutors.

Elaboration of a research work on an unpublished topic is carried out in meetings between the student and the tutor. To be able to deliver the work and present it, you must have the tutor's approval.

The defense is done in a public act where the student presents his work to a court of three doctoral professors for 20 minutes and answers the questions asked by this court.

Methodology

The basic objective of this module is the development of a research project and its defense before a court. To carry it out, as shown in the Contents section, it is based on three activities: presentation seminars, work preparation and public defense.

The seminars are the only group activity, where generic work methodologies are shown and, depending on the orientation and theme of the TFM proposals, other more specific ones. The research and development of the TFM is carried out in personalized tutorials between student and tutor. Finally the public defense, that takes place on a fixed date for the end of the semester.

Assessment

The TFM must be delivered to the module's teacher, with the tutor's approval is given. The coordination of the master's degree will determine the date of defense of the work within the month of July. This panel will consist of a doctor whose field of research is related to the subject of the work and who will act as president, the coordinator of the master's degree, who will act as the secretary, and a vowel, who will be the tutor.

The student will have 20' to present the parts that he deems appropriate in his work to leave after the interventions of the members of the court. The total approximate duration of the event will be 45 minutes.

The criteria of qualification will be defined by headings that the students will have from the first moment.
