Objectives and Contextualisation

"History of Contemporary Catalonia" is a subject of 6 credits that inserts within the subject of History along with "Prehistory and ancient history", "Medieval history", also of the second year and "History of modern Catalonia" of the third year. Part of the 60 core credits programmed for the third year are the Humanities students, together with other subjects of Classical Philology, Philosophy, Language, Art, Universal Literature, Catalan and Spanish Literature, Geography, Current World, Cultural Management and Communication The subject is a study of the main social processes and cultural events of contemporary Catalonia.

Methodology

Assessment

Theoretical tests:

- Two partial exams: 30% each of the two partial exams (60% in total)

(The first one will be done in the middle of the semester and the second at the end of the semester)

Assignments:

- Assignment 1: (25%) about a historical figure related to the world of the humanities
- Assignment 2 (15%) about a character in political history

The final grade of the subject is obtained by averaging the grades according to the percentages specified. In order to pass the subject, you must have taken both exams and both assignments.

The student who does not reach 5 points will have the right to go to the recovery exam as long as he meets these requirements:

- have both assignments delivered
- have a minimum overall grade of not less than 3
- have an average grade of the two partial exams of not less than 3.5

The student will be able to review with the professor the contents and the grades of all the tests.

The practical tests will not be recoverable and, in case the student has to recover one or both partial exams, the grade from the practical tests will stay the same when calculating the new average.

In any case, the student who has to do the recovery exams will not be able to aspire to get more than a 5 on the final grade of the course.

Other considerations: The assignments will have to be delivered on (or before) the dates stated by the professor. For each class of delay in the presentation of the assignment, the grade will be deducted 2 points. For each spelling error that appears in the text, the grade will be deducted 0.2 points.

Students who, for reasons of force majeure and can prove it in a duly accredited manner, and cannot guarantee their attendance at the face-to-face sessions, will follow a parallel evaluation that will incorporate, in addition to the components of the evaluation indicated above, a supplementary work.

The student will receive the grade ofNot assessable as long as he / she has not delivered more than 30% of evaluation activities.

In the event of a student committing any irregularity that may lead to a significant variation in the grade awarded to an assessment activity, the student will be given a zero for this activity, regardless of any disciplinary process that may take place. In the event of several irregularities in assessment activities of the same subject, the student will be given a zero as the final grade for this subject.

In the event that tests or exams cannot be taken onsite, they will be adapted to an online format made available through the UAB's virtual tools (original weighting will be maintained). Homework, activities and class participation will be carried out through forums, wikis and/or discussion on Teams, etc. Lecturers will ensure that students are able to access these virtual tools, or will offer them feasible alternatives.
