Objectives and Contextualisation

General introduction to Romanesque art

Competences

- Critically analysing from the acquired knowledge a work of art in its many facets: formal values, iconographic significance, artistic techniques and procedures, elaboration process and reception mechanisms.
- Interpreting a work of art in the context in which it was developed and relating it with other forms of cultural expression.
- Recognising the evolution of the artistic imagery from the antiquity to the contemporary visual culture.
- Students must be capable of applying their knowledge to their work or vocation in a professional way and they should have building arguments and problem resolution skills within their area of study.
- Students must develop the necessary learning skills in order to undertake further training with a high degree of autonomy.

Content

- 1. Discovery and invention of Romanesque art.
- 2. The awakening of Europe: 950-1150.
- 3. "A white robe of churches": novelty of Romanesque architecture.
- 4. The restauration of monumental sculpture: facades and historiated galleries.
- 5. The colors of Romanesque art. Forms and themes: walls, pavements, furniture, textils and books.
- 6. The Romanesque treasure. Sacred and profane: sumptuary arts.

Methodology

Master classes, class discussions and seminars, compulsory readings, individual exercises.

Annotation: Within the schedule set by the centre or degree programme, 15 minutes of one class will be reserved for students to evaluate their lecturers and their courses or modules through questionnaires.
