Objectives and Contextualisation

The aim of the course is to bring undergraduate students to the field of Labour Law in a comprehensive sense, this is the legal relationships that derive from the employment contract, trade union relations, in the Social Security, in labour court and in matters of technical liability.

An approach that will be approached from both a theoretical and practical perspective, with the involvement of students in the progressive development of the subject.

Methodology

The online modality gives a great and necessary prominence to the act of learning of the student.

This takes shape and is achieved in the autonomous activities that would be the following:

- Resolution of practical cases where the student will approach the problem of the specialty.
- Personal study in order to look for the necessary consolidation of knowledge to pass the subject.

However, this does not exclude the survival of a percentage of guided activities that would take the form of video master classes with ICT support and the inclusion of debates and forums for discussion and work with ICT support.

It is important to mention that the main objective of the video classes is to resolve the doubts related to the syllabus, therefore it is essential to prepare the topics before each session.

Finally, the student will be the subject of an evaluation, this being a summation of the marks obtained in the tests of continuous evaluation and in the examination.

Annotation: Within the schedule set by the centre or degree programme, 15 minutes of one class will be reserved for students to evaluate their lecturers and their courses or modules through questionnaires.

Assessment

Practice: 60%. Continuous evaluation by means of practical cases of the syllabus of the subject.

Theory: 40%. The exam corresponding to the final continuous assessment test scheduled in the course schedule.

The exam corresponding to the final continuous assessment test is compulsory so that all the marks of the continuous assessment can be added.

RECOVERY

In case of not passing the subject according to the aforementioned criteria (continuous assessment), a make-up test may be done on the scheduled date in the schedule, which will deal with all the contents of the program.

To participate in recovery, students must have previously been evaluated in a set of activities, the weight of which is equal to a minimum of two-thirds of the total grade for the subject. However, the grade that will appear in the student's record is a maximum of 5-Approved.
