## Objectives and Contextualisation

The subject, of a propaedeutic nature, describes and analyses from a formal and social point of view the various literary genres in Catalan literature from the end of nineteenth century onwards.

1. Individual and group exercises will be detailed at the beginning of the course.
3. Students will obtain a "Not assessed / Not submitted" course grade unless they have submitted more than 30% of the assessment items.
