Prerequisites

It is recommended that students have completed the first-year Catalan language courses and Fonètica Catalana i Estàndard Oral.

Objectives and Contextualisation

The objective of this course is to identify and characterize the main phonological processes of Catalan from a formal, rule-based derivational approach, with special attention to the most widespread dialectal varieties.

Competences

9. Characterise linguistic phenomena taking into account the different levels of analysis.
10. Correctly identify linguistic units.
11. Describe the articulatory characteristics of the sounds of Catalan.
12. Determine register types on the basis of phonology, morphology, syntax and semantics.
13. Develop effective written work and oral presentations and adapted to the appropriate register.
14. Distinguish between grammatical gender and natural gender.
15. Express oneself with orthophonic correctness in standard Catalan.
16. Gain a greater capacity for reading, interpreting and critically analysing literary and linguistic texts.
17. Identify principal and secondary ideas and express them using correct language.
18. Identify the main and secondary ideas and express them with linguistic correctness.
19. Identify the source of errors in the use of language by non-native speakers.
20. Identify the source of errors in the use of language to non-native speakers.
21. Identifying different theoretical options or ways of dealing with the same problem from alternative theoretical frameworks.
22. Identifying the main and secondary ideas and expressing them with linguistic correctness.
23. Incorporate ideas and concepts from published sources into work, citing and referencing appropriately.
24. Interpret texts in depth and provide standpoints from which to analyse them critically.
25. Justify by means of appropriate terminology the analysis of data from a linguistic point of view.
26. Locate specialised and academic information and select this according to its relevance.
27. Maintain an attitude of respect for the opinions, values, behaviors and practices of others.
28. Make appropriate use of the knowledge acquired in order to collect data and handle documentary sources in the study of Catalan language and literature.
29. Make use of the knowledge acquired while respecting diversity of opinion and varieties of a language.
30. Plan work effectively, individually or in groups, in order to fulfil the planned objectives.
31. Produce normatively correct written and oral texts.
32. Produce written and oral texts with correction rules.
33. Produce written work and oral presentations that are effective and framed in the appropriate register.

Continuous Assessment

- Test on phonetic transcription and phonological characterization in features: 10%
- Concepts test: 15%
- Exercise-solving test: 25%
- Mixed final exam: 50%

Single Assessment

- Oral practical-theoretical test: 50%
- Mixed final exam: 50% (this coincides with test 4 of the continuous assessment)

The final grade for the course will be the weighted sum of the scores obtained in each activity, which must be at least 5 (out of 10). After each test, there will always be a procedure to review the results.

A student will receive a grade of "Not assessable" if they have completed less than 30% of the assessment activities.

Only students who have obtained a minimum overall grade of 3.5 and have been assessed in at least two-thirds of the course grade components will be eligible for a resit. Only the final exam can be retaken, and the maximum grade achievable in the resit is 5.

Errors in spelling and grammar will be penalized according to the rules established for each activity.

If a student commits any irregularity that could significantly affect the grade of an assessment activity, that activity will be graded as 0, regardless of any disciplinary process that may follow. If multiple irregularities occur across activities, the final grade for the course will be 0.

In this course, the use of Artificial Intelligence (AI) technologies is not permitted in any phase. Any work that includes AI-generated content will be considered an act of academic dishonesty and may result in a partial or full grade penalty on the assignment, or more severe sanctions in serious cases.
