The eurasian lynx (Lynx lynx) is a lonely and crepuscular feline that resides in wooded areas of Europe and Asia, and which became extint in the Pyrenees at the beginning of the 20th century due to its persecution and the destruction of its habitat. It is the only big predator that has not been reintroduced in the area.




Fig 1. Eurasian lynx (*Lynx lynx*)

MATERIAL AND METHODS


